Sir,

With reference to your application on the subject cited above, recognition to your school is granted from class VI-VIII (without aid) w.e.f. 1983-84 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall appoint full time qualified and eligible staff for all classes of the school as per the present norms of the Department.
4. That the school shall equip the Science Labs as per the norms of the Department and suitable facilities for practical work shall be provided to the students and Science materials worth Rs. 2,000 (Rupees Two Thousand Only) may be purchased annually for the years from the date of recognition.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and books worth Rs. 2,000/- may be purchased annually for three years from the date of recognition.
6. That adequate sports material shall be purchased and made available to the students immediately. Sports material worth Rs. 2000/- may be purchased annually for the three years from the date of recognition.
7. That the school shall strictly abide by the provisions of Sec. 10(i) of Delhi School Education Act & Rules, 1973.
8. That the enrolment in section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of the existing four sections should not exceed the number of existing classrooms of proper size (25x18 and 13x15) in the school.

9. That the school shall not run any pre-primary and unrecognised classes of any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery class be removed from the premises of the school, if any.
10. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
11. That the scheme of management shall be got approved from the Department immediately.
12. That the service contract between the management and the employees shall be executed immediately.
13. That all the facilities prescribed under Rules 50 & 51 of the DSR, 1972 shall be made available to the students. Provisions of Rules 6, 7 and 9 be strictly observed.
14. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
15. That the management of the school shall create a reserve fund of Rs. 5,000 (Rupees Five Thousand only) in a joint account in the name of Director of Education and the Manager of the school in any scheduled bank within a month.
16. That the violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school. That class IX shall not be added to the school without the prior permission of Director of Education, Delhi.
17. That the management of the school will procure land from DDA in the name of society and construct a building as per the specification of the Department and the school will be shifted to the new site.
18. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled, shall be sent to the Education Officer every six months.

Number of sections should not exceed the number of existing classes in the school.

19. That no demand for the Grant-in Aid shall be made by the school management for the Secondary classes till the ban on creation of posts/recruitment of posts exists.
20. That Class-IX may only be added during this academic session i.e. 1985-86.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the Upgradation of the existing secondary school to senior secondary level with effect from 1992-1993 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules 1973, as well as the instructions issued from time to time.
2. That the school shall admit the students without any discrimination of caste and creed.
3. That the school will meet the additional liability of senior secondary classes by appointing more staff as per the norms of the department and subjectwise PGTs shall be appointed and Govt. nominee shall also be invited at the time of selection of the Teachers.
4. That the school shall establish and equip all the three separate science Labs. as per the norms of the Department/CBSE. Separate Lab. Assistant for each Lab. shall also be appointed.
5. That the proper Library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student and more approved standard books for senior classes and reference books for teachers shall be added.
6. That more sport material for out-door games shall be purchased and made available to the students.
7. That the school shall strictly abide by the provisions of Section 10(i) of the Delhi School Education Act 1973, and payment shall be made through crossed cheque. Bonus, LTC, medical allowance, gratuity and pension as applicable to Govt. employees of Delhi Admn. shall be paid to the employees of the school.
8. That the enrolment of each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of sections should not exceed the number of existing class rooms of proper size in the school and each class room, science Labs. and library rooms may be fitted with proper electrical appliances.
